#### **Instructions for Authors**

THE PHILIPPINE JOURNAL OF THORACIC AND CARDIOVASCULAR SURGERY publishes original articles on topics pertaining to thoracic, cardiac and vascular surgery. The journal welcomes contributions in the form of editorials, original articles, case reports, reviews, short technical (how-to-do-it) reports, special articles and letters to the editor. Statements and opinions in the contributions to the journal are those of the author(s) and do not coincide necessarily with those of the editor or publisher.

Manuscripts, preferably in English, must conform with the Uniform Requirements for Manuscripts Submitted to Biomedical Journals written by the International Committee of Medical Journal Editors (N Engl J Med 1991; 324:424-8). Manuscripts will be subject to peer review and editorial revisions may be done when needed. Accepted manuscripts automatically become the property of the Philippine Journal of Thoracic and Cardiovascular Surgery.

Three copies of the manuscript should be sent to: The Philippine Journal of Thoracic and Cardiovascular Surgery c/o Division of Thoracic and Cardiovascular Surgery, Philippine General Hospital, Taft Avenue, Manila, Philippines with telefax number 524-48-84 or telephone numbers 521-84-50 to 54 local 2460 or the secretariat at the Management Service Office, 2F Medical Arts Bldg., Philippine Heart Center, East Avenue, Diliman, Quezon City with telephone number 929-3826. All illustrations should be original and illustrations taken from other publications should have the permission of the publisher.

All investigations concerning human beings must conform to accepted ethical standards set forth in the Helsinki Declaration. Animal research should adhere to the International Guiding Principles of Biomedical Research Involving Animals recommended by the World Health Organization.

#### Preparation of Manuscripts

The paper should be typed double-spaced on one side only with margins of at least 2.5 cm with the following divisions:

TITLE PAGE: The title should be short with no abbreviations. List the full names, titles and affiliations of authors who have made significant contributions to the paper. State where the work was done, dates of conference or congress where the paper was presented, source(s) of funding, acknowledgements, and name, address, and telephone number of the author to whom all correspondence and reprint requests are to be sent.

ABSTRACT. The first page of the manuscript should have an abstract of approximately 200 to 250 words summarizing important data and presenting inferences or application of findings supported by experimental data. Following the abstract, up to 5 key words from the Medical Subjects Index (MeSH) of the Index Medicus are to be provided for subject indexing.

Text: The text should be arranged as follows:

- A short introduction stating the purpose of the investigation and the present state of knowledge of the subject.
- Materials and methods describe the subjects, methodology, equipment (name and address of the manufacturer are given as a footnote) and procedures with enough information to allow other researchers to duplicate results. Generic names for drugs should be used and units of measurement must conform to international standards.
- 3. The results should be concisely reported in the text with the help of graphs and tables and possibly processed statistically.
- 4. The discussion should comment on the results and should conform to the presented data.

REFERENCES: Number references consecutively in the order cited in the text. References should be in the standard format approved by the International Committee of Medical Journal Editors. Identify bibliographic entries in the text, graphs and tables by arabic numerals in parentheses. Personal communications and unpublished data should be cited in parentheses in the text.

#### Examples:

Standard journal article (list all authors when six or less; when seven or more, list only the first three followed by et al.).

#### Books.

Cooley DA. Surgical Treatment of Aortic Aneurysms. Philadelphia: W. B. Saunders Company, 1986:1-16.

Chapter from book.

Higenbottam TW, Wallwork J. Postoperative management, surgical complications, diagnosis and management of acute rejection. In: Cooper DKC, Novitzky D (eds). The Transplantation and Replacement of Thoracic Organs. Dordrecht: Kluwer Academic Publishers, 1990:299-305.

TABLES: Type each table on a separate sheet, numbered consecutively in roman numerals and accompanied by a short title. Explanatory notes should be placed at the foot of the table. Tables should be cited as references in the text in consecutive order.

FIGURES: Photographs should be submitted as glossy prints preferably 127 by 173 mm (5 x 7 in). The back of each photographs should be labelled with the number of the figure (arabic numerals), the title of the article, the name of the first author, and the top (orientation). Figures should be cited as references in the text in consecutive order.

Photomicrograph's should show the enlargement magnitude and method of staining if applicable. Captions should be typed on a separate sheet.

Illustrations, graphs and diagrams should be done using black ink on white paper, or using letter transfers or a computer. Typewritten or freehand lettering is not allowed. X-ray examinations should be submitted as black and white glossy prints. Electrocardiograms, etc. may be sent in their original forms or as photographs. Letters, numbers and symbols should be of sufficient size rendering them legible even when reduced. Legends for illustrations should be typed double-space on a separate sheet with arabic numerals corresponding to the illustrations.

- I. Postgraduate Course: Our 46th Foundation Day Postgraduate Course "Current Therapy in Peripheral Vascular Surgery" was held at the PHC, MAB Hall last April 15-16, 2005. This was a well attended 2 day scientific meeting.
